Amendments in Guidelines of Production Linked Incentive Scheme (PLI) for Large Scale Electronics Manufacturing

Ministry of Electronics and Information Technology notified the Production Linked Incentive Scheme (PLI) for Large Scale Electronics Manufacturing on April 01, 2020. Subsequently, Guidelines for the operation of the Scheme were notified on 1st June, 2020.


2. As per Para 12.6 of the Scheme Guidelines, "the Empowered Committee will also be authorized to carry out any amendments in Scheme Guidelines". Therefore, in accordance with Para 12.6 of the Scheme, the EC in its meeting held on 14th March, 2023 has approved the following amendment in the PLI Scheme Guidelines:
